

## Data Protection Declaration in Accordance with the Provisions of the DSGVO

This is the data protection declaration in accordance with the provisions of the DSGVO for candidates of the **Small Projects Fund** for the storage and use of personal data by GIZ in the Green People's Energy Initiative.

As the protection of personal data is very important to GIZ, we will inform you here which of your personal data is stored and what it is used for.

The responsible institution for data processing is Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH.

The purpose of processing the personal data processed under the Green People's Energy Small Projects Fund is as follows:

- The personal data (name and email address and phone number) specified in the application process <https://gruene-buengerenergie.org/en/get-involved/small-projects-fund/> and information on the project proposal, planned activities, information on funding and shared documents that is required for the purpose of GIZ initiative Green People's Energy in Eschborn, Germany will be stored on GIZ servers and used for conducting the "Small Projects Fund" application process.

The legal basis for the processing is as following:

- On the basis of Article 6(paragraph 1)( lit. b) of GDPR the processing of the above specified data is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.

GIZ secures the data by appropriate technical and organisational measures against unintentional or intended falsification, destruction, loss or access by unauthorised persons. Access to personal data is restricted to employees of Green People's Energy and supporting third parties who must process these data in accordance with the above-mentioned purpose(s) and handle them properly and confidentially.

Deletion of personal data:

Data of non-selected applicants will be deleted after a period of six months. Data of selected organization with which GIZ has concluded a contract will be deleted after the purpose has been fulfilled. The project proposals will be anonymized for project evaluation purposes. No further personal data will be processed.

### Rights of affected person

You have the right to ask for your data, to have them corrected if necessary, to request the restriction of the processing or the deletion of the data. The data will then be deleted. The permission to use the personal data can also be revoked at any time. The legality of the processing up to the time of the revocation is not affected by this.
